A dialogue tool for long-term analysis

Low-carbon, resilient development, in line with the objectives of the Paris Agreement, is inconceivable unless we design long-term trajectories for an economic, social, technological and institutional transformation.

It is in this perspective, and in accordance with France's commitments at the One Planet Summit in December 2017, that AFD created the 2050 Facility: a grant program supporting some 30 developing countries, particularly the most vulnerable and those that emit the most.





objectives

Through technical cooperation and capacity-building actions, the support provided under the 2050 Facility must help:



DEFINE REALISTIC OBJECTIVES

that combine a comprehensive vision of long-term socioeconomic development, with emission reduction targets to strengthen countries' resilience:



IDENTIFY PRIORITIES

for public and private, domestic and international investments needed to implement the structural transformations of economies in relation to long-term decarbonization and resilience;



GIVE PARTNERS THE MEANS TO TAKE INFORMED DECISIONS especially with regard to the review of planned Nationally Determined Contributions (NDC).



2 interconnected axes — of intervention

FOCUS 1

Support for the establishment of low-carbon and resilient development strategies and public policies

- Methodological support for modeling GHG emission trajectories
- Analysis of socioeconomic impacts of climate change
- Study of sectoral transition trajectories and risks of the low-carbon transition
- Support for the design of carbon pricing and emissions quotas trading systems
- Support for the revision of NDCs in line with established long-term visions

FOCUS 2

Provide support in low carbon and resilient long term planning

- Managing climate data within the countries of intervention (MRV: Measurement, Reporting, Verification)
- Planning and inclusion of low-carbon and resilient transitions in national development strategies
- Integration of climate issues in local financial institutions
- Strengthening climate policy monitoring and evaluation capacities

2050 Pathways Platform: this initiative was launched at COP22 in Marrakech to support countries willing to engage in the development of long-term low-carbon development strategies. This platform facilitates multi-stakeholder dialogue (states, cities, companies, civil society) and close coordination is ensured with the 2050 Facility in countries of joint intervention. 2050pathways.org

Deep Decarbonization Pathways (DDP):

driven by the Institute of Sustainable Development and International Relations and an international research network, the DDP initiative aims to help states and non-state actors quide economies and societies towards a carbonneutral world before the second half of the century. ddpinitiative.org

NDC Partnership:

this platform brings together a coalition of countries and institutions working together to mobilize technical and financial support to help developing countries meet their national climate commitments in the context of the Paris Agreement. ndcpartnership.org
