This first supplement (the "**First Supplement**") is supplemental to the Base Prospectus dated 8 July 2011 (the "**Base Prospectus**") granted visa no. 11-302 on 8 July 2011 by the *Autorité des marchés financiers* (the "**AMF**"), prepared by Agence Française de Développement (the "**Issuer**") with respect to the €15,000,000,000 Euro Medium Term Note Programme (the "**Programme**"). The Base Prospectus as supplemented constitutes a base prospectus for the purpose of the Directive 2003/71/EC (the "**Prospectus Directive**").

Application has been made to the AMF in France for approval of this First Supplement to the Base Prospectus, in its capacity as competent authority pursuant to Article 212-2 of its *Règlement Général* which implements the Prospectus Directive.

This First Supplement constitutes a supplement to the Base Prospectus for the purposes of Article 16.1 of the Prospectus Directive and has been prepared for the purposes of incorporating by reference the 2011 half-year financial report (the "2011 Half-Year Financial Report"), which contains *inter alia* the Issuer's 2011 consolidated half year accounts (including the auditors' report thereon and notes thereto).
