This supplement (the "**Fourth Prospectus Supplement**") is supplemental to, and should be read in conjunction with, the Base Prospectus dated 19 June 2013 granted visa no. 13-285 on 19 June 2013 by the Autorité des marchés financiers (the "**AMF**"), the first prospectus supplement dated 24 July 2013 granted visa no. 13-412 on 24 July 2013 by the AMF, the second supplement dated 10 September 2013 granted visa no 13-484 on 10 September 2013 by the AMF and the third supplement dated 14 November 2013 granted visa no. 13-612 on 14 November 2013 by the AMF (together, the "**Base Prospectus**") prepared in relation to the ϵ 25,000,000,000 Euro Medium Term Note Programme of Agence Française de Développement (the "**Issuer**"). The Base Prospectus as so supplemented constitutes a base prospectus for the purpose of the Directive 2003/71/EC as amended by Directive 2010/73/EU (the "**Prospectus Directive**").

Application has been made for approval of this Fourth Prospectus Supplement to the AMF in its capacity as competent authority pursuant to Article 212-2 of its *Règlement Général* which implements the Prospectus Directive.

This Fourth Prospectus Supplement has been prepared pursuant to Article 16.1 of the Prospectus Directive and Article 212-25 of the AMF's *Règlement Général* for the purpose of incorporating by reference the *Document de Référence*/Financial Report in the French language relating to the Issuer filed with the AMF on 30 April 2014 under no. D.14-0463 (the "**2013 Registration Document**"), which contains *inter alia* the consolidated financial statements of the Issuer as at, and for the year ending, 31 December 2013.

Save as disclosed in this Fourth Prospectus Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus which is material in the context of the Programme since the publication of the Base Prospectus.

Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Fourth Prospectus Supplement.

To the extent that there is any inconsistency between (a) any statement in this Fourth Prospectus Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.

In the case of a public offer of Notes pursuant to the Base Prospectus, investors who have already agreed to purchase or subscribe for any such Notes of the Issuer before this Fourth Prospectus Supplement is published have the right, no later than 21 May 2014 to withdraw their acceptances.
