This supplement (the "**Supplement**") is supplemental to, and should be read in conjunction with, the Base Prospectus dated 14 June 2021 granted approval no. 21-222 on 14 June 2021 by the *Autorité des marchés financiers* (the "**AMF**") (the "**Base Prospectus**") prepared in relation to the €50,000,000,000 Euro Medium Term Note Programme of Agence Française de Développement (the "**Issuer**"). Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Supplement.

The Base Prospectus as supplemented constitutes a base prospectus for the purposes of Article 8 of Regulation (EU) 2017/1129 of the European Parliament and of the European Council of 14 June 2017 (the "**Prospectus Regulation**"). This Supplement has been prepared in accordance with Article 23 of the Prospectus Regulation. Application has been made for approval of this Supplement to the AMF in its capacity as competent authority under the Prospectus Regulation.

This Supplement has been prepared for the purposes of (i) incorporating by reference the half-year financial report of the Issuer for the period ended 30 June 2021 (the "**2021 Half-Year Financial Report**"), which contains *inter alia* the Issuer's 2021 consolidated half year accounts (including the auditors' report thereon and notes thereto), (ii) amending the Risk Factors section and (iii) updating the General Information section.

Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to the information included in the Base Prospectus which is material in the context of the Programme since the publication of the Base Prospectus.

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.

MODIFICATION TO THE RISK FACTORS SECTION

The risk factor entitled "Risks related to the spread of a global epidemic" on pages 15 and 16 of the Base Prospectus shall be deleted in its entirety.

- (b) any statement contained in the 2021 Half-Year Financial Statements, the 2020 Universal Registration Document and the 2019 Universal Registration Document which is incorporated by reference herein shall be modified or superseded for the purpose of this Base Prospectus to the extent that (i) a statement contained herein modifies or supersedes such earlier statement (whether expressly, by implication or otherwise) or (ii) it is modified or incorporated by way of a supplement prepared in accordance with Article 23 of the Prospectus Regulation. Any statement so modified or superseded shall not, except as so modified or superseded, constitute a part of this Base Prospectus.

Other than in relation to the documents which are deemed to be incorporated by reference, the information on the websites to which this Base Prospectus (including, for the avoidance of doubt, any information on the websites which appear in the documents incorporated by reference) refers does not form part of this Base Prospectus and has not been scrutinised or approved by the AMF.
