### AGENCE FRANÇAISE DE DÉVELOPPEMENT EURO 60,000,000 Euro Medium Term Note Programme

This supplement (the "**Supplement**") is supplemental to, and should be read in conjunction with, the Base Prospectus dated 16 December 2022 granted approval no. 22-490 on 16 December 2022 by the *Autorité des marchés financiers* (the "**AMF**") (the "**Base Prospectus**") prepared in relation to the  $\in$ 60,000,000,000 Euro Medium Term Note Programme of Agence Française de Développement (the "**Issuer**"). Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Supplement.

The Base Prospectus as supplemented constitutes a base prospectus for the purposes of Article 8 of Regulation (EU) 2017/1129 of the European Parliament and of the European Council of 14 June 2017 (the "**Prospectus Regulation**"). This Supplement has been prepared in accordance with Article 23 of the Prospectus Regulation. Application has been made for approval of this Supplement to the AMF in its capacity as competent authority under the Prospectus Regulation.

This Supplement has been prepared for the purposes of (i) updating the Risk Factor section, (ii) incorporating by reference the *Document d'Enregistrement Universel* in the French language relating to the Issuer filed with the AMF on 26 April 2023 under no. D.23-0334, which contains the audited consolidated financial statements of the Issuer as at, and for the year ending, 31 December 2022, (iii) updating the General Information on the Issuer section and (iv) updating the General Information section of the Base Prospectus.

Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to the information included in the Base Prospectus, which is material in the context of the Programme, since the publication of the Base Prospectus.

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.

### **RISK FACTORS**

Part 1 (*Risk factors relating to the Issuer*) of the "Risk Factors" section on page 8 of the Base Prospectus shall be deleted and replaced with the following:

"AFD's activities focus mainly on the financing of development projects in foreign countries and in the French Overseas Territories. The various risks associated with this financial activity and with the countries of operation must be strictly monitored. These various risk factors are therefore monitored and managed according to the nature of the risk and according to the geographical region concerned.

Please note that, although monitored and managed, the risks described on pages 106 to 114 of the French language *Document d'enregistrement universel* of the Issuer for the financial year 2022 (the "**2022 Universal Registration Document**") which was filed with the AMF on 26 April 2023 under registration number D. 23-0334 and which pages are incorporated by reference herein in the section "*Documents incorporated by reference*" below and those corresponding to the classification provided for by the Ministerial Order (*Arrêté*) dated 3 November 2014 cannot be totally eliminated."

"BDO and KPMG S.A. have audited and rendered unqualified audit reports on the consolidated financial statements of the Issuer for the years ended 31 December 2021 and 31 December 2022.

BDO and KPMG S.A. are registered as Commissaires aux Comptes (members of the Compagnie Nationale des Commissaires aux Comptes)."
